### Potential Health Effects

#### (Acute and Chronic):

<b>Inhalation:</b>	May cause severe irritation of the respiratory tract with sore throat, coughing, shortness of breath and delayed lung edema. Irritation may lead to chemical pneumonitis and pulmonary edema. Causes severe irritation of upper respiratory tract with coughing, burns, breathing difficulty, and possible coma. Causes chemical burns to the respiratory tract.
<b>Skin Contact:</b>	Causes skin irritation. Causes skin burns. May cause skin rash (in milder cases), and cold and clammy skin with cyanosis or pale color.
<b>Eye Contact:</b>	Causes eye irritation. Causes eye burns. May cause chemical conjunctivitis and corneal damage.
